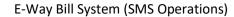

1. Introduction

1.1 Background

Introduction of Goods and Services Tax (GST) across India with effect from 1st of July 2017 is a very significant step in the field of indirect tax reforms in India. For quick and easy movement of goods across India without any hindrance, all the check posts across the country are abolished. The GST system provides a provision of e-Way Bill, a document to be carried by the person in charge of conveyance, generated electronically from the common portal. To implement the e-Way Bill system, ICT based solution is required. Hence, as approved by the Goods and Services Tax (GST) Council, a web based solution has been designed and developed by National Informatics Centre and it is being rolled out for the use of taxpayers and transporters. To ease the operation of e-way bill generation, the SMS based facility is provided to generate the e-way bills.

1.2 Purpose and Intended Audience

This document aims to explain the operational procedure on how to use SMS based e-Way Bill system. Also it explains the features and roles of the stake holders in using this system.

This document is intended for registered taxpayers under GST and un-registered transporters, who are the main stakeholders of e-Way Bill system under GST.

1.3 Scope

The scope of this document covers the activities of e-way bills using the SMS facility.

2. EWB Statistics through SMS

2.1 Daily SMS Alerts to Tax Payers

Every day the following message will be sent to all the Tax Payers based on the activities related to his GSTIN performed on previous day. This message is sent to the GST registered mobile number. This message contains the e-way bills generated by him and also other parties generated on his/her GSTIN as consignee/consignor. This information is for one day as a alert to each tax payers. Based on this data, the in case of variations in the figures, the tax payers can go to the web site and check and cancellation and rejection can be done accordingly. Thus message will come even if the tax payer has not registered on the e-way bill portal.

2.2 Getting the Statistics for E-Way Bill

This section explains how to use the SMS facility to get the statistics of all the E-Way Bill activities related to GSTIN of the User for previous date.

3. SMS Operations

Mobile E-Way Bill is a mobile SMS based generation of e-way bill. This is meant for small tax payers, who may not have IT systems and may not have large number of transactions for e-way bill generation in a day. This can also be used by tax payers to generate e-Way Bill, in emergency cases like night, for urgent movement of transactions.

The tax payer shall be able to perform following activities related to the e-Way Bill system using SMS based operations:

- Generate the E-Way Bill
- Update the Vehicle Details
- Cancel the E-Way Bill
- Update the Transporter
- Get E-Way Bills generated by other party
- Reject the E-Way Bill

This is a very simple method of e-Way Bill generation. However, the tax payer has to take care of sending the request for e-Way Bill, in proper format and without any mistake during the data entry in mobile. Otherwise, the E-way bill may be generated with wrong information.

To use this method, the tax payer has to register his mobile number, which is going to be used for e-Way Bill generation, on the web portal. The system enables only for that mobile number of the tax payer (GSTIN) to generate e-Way Bill for that GSTIN. This facility is also available for transporter.

3.1 Pre-requisite for using SMS facility


To use this service, the tax payer or transporter has to open the e-way bill portal and login using his/her username and password and go to 'Registration' menu and 'for SMS' option. Here he/she will be requested to select the user and particulars of user are shown with mobile number as shown in the below screenshots. The tax payer/transporter can register only one mobile number for the e-Way Bill purpose.

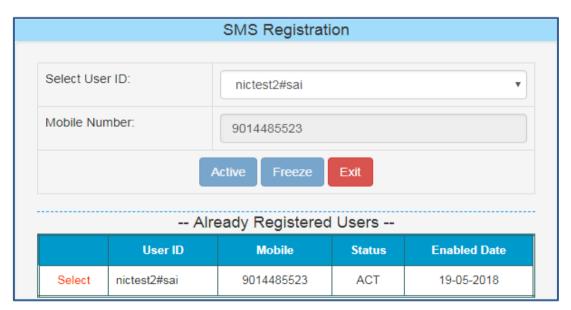




SMS Registration screenshots

4. Validations

The system will carry out the following validations before processing the SMS request. In case of failure of validation, the system sends the appropriate error message to the mobile number.

- The system will validate the registered mobile number with the tax payer/transporter before accepting the request.
- The system will validate the correct keyword EWBG/EWBT for E-way Bill Generate Request; EWBV for E-Way Bill vehicle update Request; EWBC for E-Way Bill Cancel Request; EWBU for Update Transporter Request; EWBR for reject E-Way Bill Request; EWBS for Get E-Way Bill Statistics; EWBL for List of E-way Bills generated by other party.
- For generation, the system will validate the correctness of codes for Transaction TYPE –
 OSUP, OEXP, OJOB, OSCD,ORNK,OFOU, OEOF, OLNS, OOTH ISUP, IIMP, IFOU,
 ISCD, IJWR, ISLR, IEOF, IOTH, IFOU
- For generation, the system will verify the GSTIN of the recipient, if 15 chars have been provided.
- For generation, the system will validate the HSN Code with the HSN master codes.
- For generation, the system checks the format of DelPinCode, InvDate, InvNo and Vehicle parameters
- The cancellation is allowed only for generator of the e-Way Bill.
- The Vehicle Updating is allowed for the tax payer who has generated or transporter who has been authorized while generating the e-waybill.
- The cancellation is allowed with 24 hours of generation of e-Way Bill
- The Vehicle updating is allowed with validity period as per the distance mentioned in e-Way Bill.
- The verified e-waybill cannot be cancelled.
- The other party is allowed to reject the E-way bill within 72 hours of generation of e-Way Bill.





5. Generate the E-Way Bill - Taxpayer

This section explains how to use the SMS facility to generate the new E-Way Bill Number from the E-Way Bill system.

- If the list contains more than 10 E-way bills, the taxpayer/transporter needs to visit the website to get complete list.

- Requestor has to register his mobile number in E-Way Bill portal for using SMS facility.
- Requestor GSTIN/TRANSIN should be linked to the registered mobile number.





11. Reject the E-Way Bill- Tax Payer or Transporter

- Requestor should have the EWB No. which is generated by other party and he wants to reject.
