E-Way Bill system (https://ewaybillgst.gov.in) has been implemented from April 2018 throughout the country and it is running successfully for last 6 years. More than 480 Crores are e-way bills have been generated. Subsequently, as per the request, E-Invoice1 system has been built and rolled out three and half years back. During last 3 and half years, tax payers have generated more than 600 Crores e-invoices from this portal. These systems are running with 24/7 services for last 6 years without any down time. e-Waybill and e-Invoice1 Systems have Business Continuity Plan (BCP) setup at Hyderabad. As per the request of GSTN, we have started the second e-invoice portal, as parallel portal, at Hyderabad from March 2023. GSTN has also established 4 more e-invoice portals for the ease and quick availability of the e-invoice generation for tax payers.

NIC is happy to inform that e-way bill2 portal will be released on 1st June 2024 with URL https://ewaybill2.gst.gov.in from Hyderabad, to provide the high availability of e-way bill services. This system runs in parallel with e-Way bill System at Delhi, but with the critical functionalities. The tax payers and logistics operators can use the existing username and password created and used in the e-way bill portal. Data of the E-way bill2 portal will be validated, merged and made available at primary e-way bill portal for the all the business and analytical purposes. This portal is also integrated with additional e-invoice portal for e-way bill generation so as not to affect the e-invoice generation with e-way bill.

E-Way Bills can be generated and updated on the E-Way Bill2 Portal independently. Eventually, e-way bill1 and e-Waybill2 system will get seamlessly merged and integrated and this will eliminate the dependency on e-Waybill1 system, during any exigencies. The e-way bill2 portal synchronises the e-way bill details with main portal within a few seconds.

The Criss-cross operations of printing and updating of Part-B of E-Way Bills can be carried out on these portals. That is, updating the E-Way bills of the e-way bill1 portal can be done at e-way bill2 portal and vice versa. In case E-Way Bill main portal is non-operational because of technical reasons, the Part-B can be

updated to the E-Way Bills, generated at e-way bill1 Portal, at e-way bill2 portal and carry both the E-way Bill slips.

E-Way Bill2 web Portal will provide the following critical services to the tax payers and logistic operators:

- Generate E-Way Bills
- Update Vehicle Details
- Update Transporter Details
- Print E-Way Bills
- Cancel E-Way Bills

The other services/operations of the E-way Bill system will be provided on the E-way Bill2 portal in near future.

In addition to the e-way bill web portal, the following APIs are available for the tax payers and logistic operators:

- Generate E-Way Bill
- Update Vehicle Details
- Update Transporter Details
- Get E-Way Bill
- Cancel E-Way Bill
